

## 2018 Rock-a-Rama Vendor Terms & Agreement

1. High Desert Helpers, Inc. (hereinafter referred to as HDH) is hosting an open air Gem and Mineral show November 2, 3, & 4, 2018.
2. To reserve your 15' x 15' space for the 3 show days, a fee of \$65 must be paid in full before November 24, 2017, accompanied by this completed contract application (first come, first served, and the date received will be based on the post mark if sent through a mail carrier). After November 24, 2017 the fee will increase to \$75. Checks must be made out to High Desert Helpers, Inc. (NSF checks will be assessed a \$35 fee). All entries received after September 30, 2018 will be \$95 and payment must be made in cash or by POSTAL money order.
3. All cancellations must be made in writing. No refunds will be given for cancellations made less than 90 days prior to the event. Show will go on, wind, rain, or shine.
4. Vendor wares should be 80% rock, gem, mineral or jewelry related. No yard sales, please.
5. Vendors must provide their own tables, business cards and appropriate display labels, tents/easy ups, and electricity if needed. They are also responsible for any required state sales tax license.
6. Vendor agrees to indemnify and hold harmless HDH, and its members from and against any and all claims for damages, losses or liabilities arising out of show.
7. During Rock-a-Rama, HDH may take photos of vendors and their merchandise to promote the event. I agree that HDH may use such photographs for any lawful purpose, including such purposes as publicity, illustration, advertising, and website content.
8. Neither HDH nor any of its members or volunteers assumes any liability for the personal safety of vendor or their representatives or for any loss due to pilferage, fire, theft or from any other cause.
9. HDH reserves the right to remove any person, exhibit, advertising, feature or practice that it finds objectionable. No sales, use, or showing of alcoholic beverages, drugs, or materials of a pornographic nature is allowed. All materials exhibited or offered for sale must be accurately represented or labeled. Any vendor in violation of these rules will be referred to the Yavapai County Sheriff's Office for removal and there will be no refund of fees paid.
10. Quiet hours are between 9:00 PM and 6:00 AM. No generator use allowed during this time.
11. HDH reserves the right to sell items at a club booth during the show.
